ETCHELLS GUEST REGISTRATION FORM

BBYC CLUB POLICY

It is the policy of the Biscayne Bay Yacht Club to offer it's facilities to the use of guests associated with both local and national racing events. There are no storage fees for boats arriving not more than one day before and departing not more than one day after racing in a Regatta. We ask all guests to please observe the rules as posted and to respect the activities of club members as well as to protection of club property while you are visiting.

ETCHELLS BOAT STORAGE

Biscayne Bay Yacht Club will accept visiting Etchells for **2008 JAGUAR CUP** storage on a first to apply, first accepted basis. There are approximately 30 spaces available at BBYC for visiting Etchells, and once filled, BBYC will not accept additional applications for storage. Storage fees of \$70.00 per week (or any part thereof), plus Florida State tax of 7%, will be charged for boat and trailer storage at BBYC. Storage charges will be billed directly by BBYC each month. Visiting Etchells participating in the Jaguar Cup Series **should not arrive** on BBYC grounds prior to November 23, 2007, or remain stored on BBYC grounds after March 10, 2008. Trailers must have clearly marked owner information attached to the stern upright. Alternative arrangements for storage in the local area after March 10, 2008 may be found at the US Sailing Center (www.usscmiami.org), or Shake-A-Leg Miami (www.shakealegmiami.org).

VEHICLE PARKING

Vehicles **shall not** be stored at BBYC between events. Off site parking facilities are available in the local area. Check with the Etchells Fleet 20 website (www.etchellsfleet20.org) for a listing of parking facilities nearby. During events, parking is a premium and we ask all guests to please observe all parking notices. No boats or trailers are to be left un-attended on the black top prior to or after launch. All trailers **must** be parked on the west lawn or in a specific space assigned by the shore manager.

LAUNCHING / RIGGING / HOIST AREA

Stepping and rigging masts must be done in an area that does not obstruct movement of other boats and trailers. Competitors vehicles are not allowed in the launching / rigging area at any time. BBYC will have personnel and tractors available to move Etchells and trailers to and from the hoist area.

WET SLIP ASSIGNMENT

Once launched, boats must take an assigned slip or raft-up on the pier heads and should not remain in the launching basin. The BBYC Shore Manager will have a list of available slips and rafting areas.

HOUSE CHARGES

The Club bar and food service facilities are available to all registered guest skippers and crewmembers on a "cash" basis unless prior arrangement has been made with the Club Manager. Visitors' accounts can be set up by completing this registration form and a billing security agreement. A credit card imprint will be made upon registration at the club to insure payment. Billing security agreements will be available at registration.

SECURITY

Biscayne Bay Yacht Club does not accept any liability for vehicles, boats or trailers on the premises, and as such, all guests should take appropriate action to best secure individual personal items. Yacht Club Rules prohibit overnight camping and/or sleeping in vehicles on the club grounds. Club access through the main gate is a responsibility for all guests, and the utmost care should be taken to prevent un-authorized access.
